Board Meeting

The June 2023 Tallahassee Collegiate Academy (TCA) Board of Trustees meeting was called to order by Vice Chair Clark at approximately 6:00 p.m.

Members Present: Vice-Chair Clark, Trustees Kelling, and Pople.

APPROVAL OF MINUTES

1. May 23, 2023 Meeting

Requested Board approve minutes as presented.

MOTION: Trustee Pople SECOND: Trustee Kelling

Motion passed unanimously.

NEW BUSINESS

a. Governance Training Reminder

Principal Jessica Chapman confirmed the training will be held on June 22, 2023, 10:00 a.m. – 2:00 p.m. with the Sean Arnold Law Firm. Chair Moore indicated that she would need a recording of the training, as she could not attend in person.

b. Enrollment Updates

Principal Chapman explained that there were 181 students fully enrolled, with an average of five new applicants per week. Within the last month, there were 31 new applications received, projecting that the goal of 200 students would be met by the start of the academic school year.

c. Policy Workshop

Barbara Wills, TCC's Vice President of Administrative Services explained that she worked with an organization called Neola which is a professional policy development team to draft the policies for TCA. There is a legal guarantee that the organization can provide and consult with local counsel. VP Wills provided an overview of the policies.

Trustee Pople asked if there was statutory language for personnel in charter schools. VP Wills indicated that there were specific policies for K-12, such as, reporting requirements for arrests and the Jessica Lunsford Act background screening. Trustee Clark asked if there was parity between TCC and TCA employee benefits. VP Wills clarified that the information was included. Trustee Clark asked about the cost and the familiarity of utilizing the platform at the college. VP Wills clarified that TCC has utilized the platform for about three years and the cost is approximately \$7000 annually. Chair Moore indicated that she had the opportunity to review the

platforms prior to the board meeting and confirmed that the platform has a clear and understandable usage. Policies will be reviewed and voted on for the July meeting.

d. Hiring Updates

Principal Chapman introduced Matthew Gregory as the charter school's dean of students. For information only, no Board action required.

The team is ready for its final walk through by DOE's Office of Safe Schools who will visit the school and check for safety compliance.

b. Budget Presentation

i. This presentation was provided by VP Wills. Trustee Pople asked for clarity on the \$2.1 Million grant that is effective through September. VP Wills clarified that the grant is usable through September 30 with additional details on the items that will be used by the grant through that timeline. Vice Chair Clark and Trustee Pople asked for a more detailed budget to be provided in the future. Trustee Pople indicated that the high-level budget is acceptable for the need of an approval. VP Wills asked if a more detailed budget should be shared at the next board meeting. Vice Chair Clark confirmed that sharing that document would be more helpful during the next board meeting. Vice Chair Clark requested a motion for approval of the estimated budget.

MOTION: Trustee Pople **SECOND**: Trustee Kelling Motion passes unanimously.

c. Contract for Services

- i. VP Wills reviewed the MOU for services. The charter contract was not on the agenda. Vice Chair Clark asked for the protocols for items not on the agenda. VP Wills clarified that one of the board members can make a recommendation to add an item to the agenda.
- ii. Chair Moore made a motion to add the charter agreement as an agenda item for this board meeting.

MOTION: Vice Chair Clark **SECOND**: Trustee Kelling Motion passed unanimously.

iii. Vice Chair Clark made a motion to vote on the charter agreement and MOU for services for approval.

MOTION: Trustee Pople **SECOND**: Trustee Kelling Motion passed unanimously.

d. Dual-Enrollment Agreement between TCA and TCC

i. Principal Chapman explained the dual enrollment agreement. Trustee Pople requested clarity on page 2 regarding the instruction. Principal Chapman clarified that the charter school will not be employing teachers for 11th and 12th grade so the funding is available to pay for the students' books and fees for this school year.

- ii. Chair Moore made a motion for approval of the dual enrollment agreement.
 MOTION: Chair Moore SECOND: Trustee Pople Motion passed unanimously.
- e. Reading Plan TCA to FLDOE Jessica Chapman
 - i. Principal Chapman asked for a board approval for the Reading Plan. Trustee Pople expressed his curiosity on the plan being shared to students. Principal Chapman explained that DOE requires it to be coded on the students' schedule by FLDOE. Trustee Kelling asked if the charter school will test the students on reading deficiencies as they enter the school. Principal Chapman's response included details that each students' test scores are received within the enrollment process.

MOTION: Trustee Kelling **SECOND**: Trustee Pople Motion passed unanimously.
