On February 17, 2025, the Tallahassee Collegiate Academy (TCA) Board of Trustees meeting was called to order by Trustee Karen Moore at 6:02 p.m.

### **NEW BUSINESS**

### a. Principal's Report

Assistant Principal Pagozalski provided an update on recent TCA events. The past TCA Board Meeting scheduled for January was cancelled due to snow. When students returned to school, they celebrated Literacy Week with many events, ending with our 10<sup>th</sup> graders attending the Zora festival in Eatonville, FL and had the opportunity to present and share their projects with festival goers. TCA's involvement in the Zora festival is hoping to grow in the coming years.

Dean Gregory shared the student led initiatives that had culminated in the many events TCA has planned for Black History Month, including Family Feud, food trucks, the spoken word event, and the BHM Field Trip for all 9<sup>th</sup> grade students to FAMU, the Black Archives, and the IMAX theatre. Ms. Chapman and her Culture Club were credited with the hard work needed to make these events possible. In addition to this, students also got to experience the Hate Ends Now Holocaust traveling exhibit, featuring 360 video presentation of stories from Holocaust survivors.

TCA students are also participating in Plant the Moon Science competition, where they are investigating plant growth in lunar conditions utilizing moon simulant soil.

Assistant Principal Pagozalski provided an update on the COGNIA accreditation process. On February 4<sup>th</sup>, COGNIA conducted their last visit to TCA and spent the day observing classrooms and seeing school operations, as well as having the opportunity to sit down and speak with TCA teachers. The COGNIA evaluator had high remarks for TCA and are currently working on the final report.

### b. Enrollment Update

Update provided by Assistant Principal Pagozalski. At the time of this memorandum, there were 275 students enrolled: 114 9<sup>th</sup> graders, 99 10<sup>th</sup> graders, 49 11<sup>th</sup> graders, and 13 12<sup>th</sup> graders. Enrollment was at 275 students during the February FTE report, reflecting the same FTE numbers to those reported in October.

#### c. Academic Update

Update provided by Assistant Principal Pagozalski. An update on the academic achievement goals for the 2024-2025 school year was provided for the subjects of ELA, Math, US History and Biology. In ELA, the initial academic goal was set for 64% proficiency, and students are currently at 61% proficiency. Testing data from PM1 and PM2 were analyzed by the literacy leadership team and additional support was determined for students to excel in PM3. In Math, the initial academic goal was set for 64% proficiency, and students are currently at 65% proficiency. Math tutoring is offered every Monday and Thursday. In US History, the initial academic goal was set for an 80% EOC pass rate, and students are currently at an 80% EOC pass rate. US History tutoring is offered every Wednesday. In Biology, the initial academic goal was set for an 85% EOC pass rate and students are currently at an 69% EOC pass rate. Biology tutoring is offered every Wednesday. In addition to this support, TCA students also have Power Hour for either intervention or enrichment on Wednesdays, PM Power Hour includes extending support after school on Wednesdays, EOC Exam Jam sessions, as well as the intensive reading course. Dual Enrollment numbers for TCA students have increased this semester, to a total of 156 students taking DE courses in Spring. Trustee Taylor was curious as to how TCA is performing compared to other schools in the state; this information was requested by Trustee Moore to be brought to the next board meeting.

### **Overview and Background**

TCA has 275 students enrolled as follows: 9<sup>th</sup> graders = 114, 10<sup>th</sup> graders = 99, 11<sup>th</sup> graders = 49 and 12<sup>th</sup> graders = 13. Seats were offered to students on the waitlist to fill open seats. The goal was to increase enrollment numbers by three students before the February FTE report to reflect the same numbers reported in October. This goal was accomplished.

SUBJECT: Academic Update

### Item Description

This item provides an update regarding academic and student progress at TCA.

### **Overview and Background**

Schools develop academic achievement goals each year to monitor the teaching and learning outcomes. During the October meeting, the TCA board approved the academic achievement goals for the year. This item provides an academic update on the goals.

<u>ELA:</u> PM2 Test was given on December 10, 2024. Our initial academic goal was set for 64% proficiency, and we are currently at 61% proficiency, scoring a level 3 or higher. We adjusted schedules and updated student supports to ensure that all of our students have the most support needed to excel.

<u>Math:</u> Students are preparing to take the End of Course (EOC) exams in May. The initial academic goal was set for 64% proficiency. After school math tutoring began the second week in January and students were invited via parent email based on test scores, progress monitoring and current class grades.

<u>US History</u>: Students are preparing to take the End of Course (EOC) exams in May. Students took a mid-year progress monitoring assessment on January 10<sup>th</sup> and 11<sup>th</sup>. Our initial academic goal was set at 80% pass rate for EOC. We are currently projected at 80% projected to pass US History EOC. Plans for tutoring is being arranged to work with the students.

<u>Biology</u>: Students are preparing to take the End of Course (EOC) exams in May. Students who are struggling will have extra support in Biology during power hour and are invited to tutoring each Wednesday. Our initial academic goal was set for 85%, we are currently at 69% projected to pass Biology EOC.

<u>After-School Tutoring</u>: We are using funds to pay teachers extra hours to host "PM Power Hour". We offer Power Hour on Wednesdays at lunch, and our staff had the idea of extending this focused intervention and enrichment time to the students that need it the most after the school day ends. Students will have an opportunity to stay after school on Wednesdays for additional support from several teachers. In addition, EOC courses will host four Exam Jam extended tutoring sessions in April.

<u>Dual-Enrollment:</u> Our dual enrollment program has expanded significantly. We have added over 70 students to the dual-enrollment track and currently have 153 students taking one or more dual-enrollment courses. As we grow and move closer to ensuring all students are dual-enrollment ready, we are working on aligning more with TCA's mission.

Many students in 10<sup>th</sup> grade are enrolled in the dual enrollment class SLS 1510 (College Success). We currently have 80 students enrolled in this course. This course serves as a student support intervention to prepare students for the college experience.

# **Overview and Background**

In accordance with Florida Statute1002.33(9) the governing board of the charter school shall annually adopt and maintain an operating budget. The LEA and School monitors the operating fund activity to ensure approved budget limits are maintained. This form is provided in accordance with Statute, which requires charter schools to provide annual financial report and program cost report information in the state-required formats for reporting.

The 24-25 budget is based on an enrollment of 275 students and using the Florida Department of Education revenue generating formula for charter schools. The budget maintains a 5% contingency and a balanced budget.
